


PRP Tuition Information

The Parish Religion Program at Immaculate Heart of Mary exists to serve the formation needs of its parishioners. Tuition covers approximately 40% of the cost for the PRP at Immaculate Heart of Mary. Our parish shares the responsibility of educating its children in the faith for **registered parents who are active in the life of the parish community**. *The real cost of educating our PRP children is \$390. per child.* The Administration and Finance Commission of the parish determines PRP tuition. Every attempt is made to keep increases at a minimum. The tuition this year will have a \$10.00 across the board increase. This is the first time tuition has been raised in ten years. Tuition covers books, materials, catechist support, and formation opportunities.

Parish Religion Program fees for summer and winter sessions are:

Active IHM Parishioners:	
1 child	\$135.
2 children	\$185.
3 children or more	\$210.

*Family Option tuition will be adjusted to reflect the difference in programming; those interested in the family option will discuss tuition during their initial meeting with formation staff.

Active parishioners are those who regularly worship at Immaculate Heart of Mary Parish, or at another parish from which they have recently moved, and have done so for a minimum of six months prior to registration including all of the following: regular Sunday Mass attendance, support of sacramental programs, participation in religious formation programs. A yearly stewardship pledge with fulfillment: volunteer time and talent in ministries and organizations associated with the parish, financial support of the church to the best of the family's ability.

Parishioner status will be reviewed on an annual basis. Families who do not fulfill the above will be considered non-parishioners and assessed non-parishioner tuition (\$390./child) for the following year. Please contact the office if special circumstances occur.

Baptismal Certificates:

Unless a child was baptized at Immaculate Heart of Mary Parish, it is essential that we have a **copy** of his/her baptismal certificate on file. All **new** families must attach this to their registration form. The copy does not need to be an "official" duplicate sealed by the parish. No child is fully registered in PRP until a baptismal certificate is received by our office.
